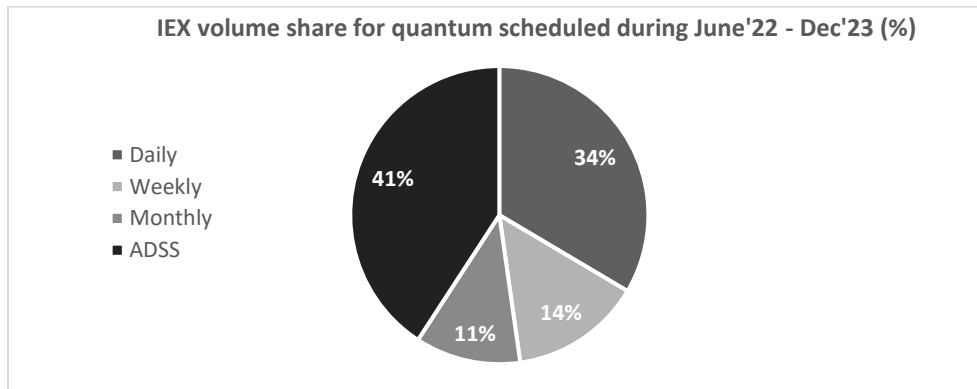

Public Notice

IEX invites comments/suggestions on Petition No. 383/MP/2023 filed before CERC for approval of the revised Business Rules for extension of the TAM and G-TAM Contracts upto 11 months and alignment with the provisions of GNA Regulations 2022, IEGC Regulations 2023, and Amendment to Sharing of ISTS Charges and Losses Regulations 2023

Indian Energy Exchange Limited (IEX) filed a Petition dated 29.11.2023 before the Hon'ble CERC for approval of revised Business Rules for extension of the TAM and G-TAM Contracts upto 11 months at IEX and alignment with the provisions of GNA Regulations 2022, IEGC Regulations 2023, and Amendment to Sharing of ISTS Charges and Losses Regulations 2023. Subsequently, Para 8 of the Petition has been restated with rectified data and may be read as below:

"8. In the aforesaid TAM/GTAM contracts at IEX, from June'22 to Dec'23, out of a total of 3057 MUs scheduled in daily contracts, 1183 MUs (39% of the total) were delivered in the Long Duration Contract (LDC) mode (more than T+11). Further, out of a total of 1299 MUs scheduled in weekly contracts, 13 MUs (1% of the total) were delivered in the LDC mode. In case of the monthly contracts, from a total of 1044 MUs scheduled in monthly contracts, 1042 MUs (~100% of the total) were delivered in the LDC mode. In Any-Day(s) Single Sided contracts (ADSS) contracts, from a total of 3722 MUs scheduled in ADSS contracts, 2021 MUs (54% of the total) were delivered in the LDC mode. The distribution of volume Monthly/Weekly/Daily/ADSS contracts is shown below:
